- Tom Jenkins who was appointed Fire Chief for the City of Rogers, Arkansas on January 16, 2009. In this capacity he is responsible for over 150 career firefighters in ten locations. Chief Jenkins has served under Governors Beebe and Hutchison on several state commissions and groups, including the Trauma Advisory Council, the Firefighter Benefit Review Panel and the Safe Schools Commission. Chief Jenkins has served as a professor for both Northwest Arkansas Community College, Drury University and Oklahoma State University, teaching topics that range from leadership and administration to fire hydraulics and suppression tactics. Chief Jenkins served as the President of the International Association of Fire Chiefs from 2017-2018.
- Catherine Lotrionte is a Senior Researcher at Georgetown
  University, a Senior Associate in the Technology Policy Program at
  the Center for Strategic and International Studies and a Senior Fellow
  at the McCrary Institute for Cyber and Critical Infrastructure Security
  at Auburn University. Previously she served as the Brent Scowcroft
  scholar at the Atlantic Council. She is also the founder and former
  Director of the CyberProject at Georgetown University, where she
  has taught and written on international and national security law,
  international affairs and technology. At Georgetown she founded the
  Annual International Conference on Cyber Engagement which draws
  on the experience of government practitioners, industry
  representatives and academic scholars, providing technical, corporate,
  legal and policy perspectives from the international community.
