#### Abstract:

The Philadelphia Police Department Intelligence Bureau/Delaware Valley Intelligence Center (DVIC) has an established Fusion Liaison Officer program that promotes the collection of suspicious activity reporting and other criminal activity through a combination of basic and specialized training classes and outreach. Currently, the FLO program has approximately 150 FLOs, which comprises every patrol district, detective division and special unit within the PPD and regional law enforcement agencies as well as private sector personnel from the Philadelphia metropolitan area. The PPD officers and private sector personnel are our force multiplier in the collection of information related to targeted violence and terrorism. The Intelligence Bureau wants to expand this program. Specifically, the content of the current training will be expanded to include a focus on violent extremism indicators as well as the behavioral indicators of targeted violence. The expansion of the program would also include significantly increasing the number of trainings, specifically outreach to all personnel in the PPD patrol districts. These program enhancements should increase awareness of the targeted violence and terrorism indicators and result in increased reporting and prevention of this type of violence in the Philadelphia.

#### 1. Needs Assessment

The Philadelphia Police Department Intelligence Bureau/Delaware Valley Intelligence Center (DVIC) has an established Fusion Liaison Officer program that promotes the collection of suspicious activity reporting and other criminal activity through a combination of basic and specialized training classes and outreach. The program also provides Privacy Civil Rights and Liberties training. Currently, the FLO program has approximately 150 FLOs, which comprises every patrol district, detective division and special unit within the PPD and regional law enforcement agencies as well as private sector personnel from the Philadelphia metropolitan area. The Intelligence Bureau wants to expand this program, which will require additional resources for training, outreach, and training materials. Specifically, the PPD officers are our force multiplier in the collection of information related to targeted violence and terrorism on the streets. During the period of performance, the training content would be expanded to include a focus on violent extremism indicators with specific local examples as well as the behavioral indicators of targeted violence. Second, the number of training would be expanded with a specific focus on outreach to all personnel in the patrol districts (approximately 4,500 personnel). This will require additional resources to employ the use of Intelligence Bureau personnel for additional hours to support training on all three shifts. Providing training and outreach to all the patrol officers should increase awareness of the targeted violence and terrorism indicators and result in increased reporting to the Intelligence Bureau. The increased outreach should fill the gap of having limited personnel trained within the PPD with the goal of providing training to the over four thousand PPD patrol officers and supervisors.

#### 2. Program Design

<u>Problem Statement:</u> The PPD Intelligence Bureau would like to increase the collection of information and intelligence related to targeted violence and terrorism through the expansion of PPD Intelligence Bureau/DVIC Fusion Liaison Officer Program. The collection and analysis of this intelligence will increase the safety of the Philadelphia metropolitan area.

Currently, the Fusion Liaison Officer program has trained several local and regional law enforcement and private sector personnel with a focus on terrorism prevention. The program requires enhanced curriculum to include indicators of targeted violence, additional training classes and a significant increase in outreach. In order to bring the program to the next level, the Intelligence Bureau requires funding to support the purchase of training materials and additional work hours needed for our FLO coordinators to provide training/outreach on all shifts to reach the maximum number of officers. The key to the increased collection and reporting of potential acts of violence is training many officers. Through community policing, the officers will reach out to

community leaders, faith-based leaders, and others within their area of responsibility to build relationships to further increase the reporting of potential threats of violence.

#### Program goals and objectives:

<u>Goals:</u> The goal of the program is to train Philadelphia regional law enforcement and private sector personnel on the indicators of targeted violence and terrorism. Specifically, provide training and outreach to the majority of PPD patrol personnel on the indicators of targeted violence and terrorism as well as specific issues related to these topics in Philadelphia. The enhanced topics and increased training should result in increased reporting of information related to potential threats of violence to the PPD Intelligence Bureau and therefore, result in prevention such acts within the region.

#### Objectives:

- 1- The program will perform ten training classes to include PPD and regional law enforcement. This will train approximately 250 fusion liaison officers.
- 2- The program will conduct 130 outreaches to the Philadelphia Police Department patrol operations.
- 3- The program will conduct five training classes to the private sector. This will train approximately 125 private sector partners.
- 4- Provide pre- and post- training surveys to determine effectiveness of training in terms of knowledge gained about indicators of targeted violence and terrorism.

# Logic Model

Theory of Change: The changes described in the logic model are expected to occur because based on previous experience with the existing program, performing outreach, networking with the officers and following up with them on a regular basis has resulted in an increase in reporting of information related to potential terrorism incidents. Based on the proposed program changes to include additional indicators of targeted violence and terrorism and to significantly increase the training classes and outreach, the reporting of potential violence to the Intelligence Bureau should increase and thereby result in the prevention of violence in the Philadelphia Metropolitan Regions.

PROGRAM: Targeted violence and terrorism training and awareness raising

GOAL: Prevent acts of targeted violence and terrorism by increasing the awareness of indicators of violent extremism through training and outreach.

#### 3. Organization and Key Personnel

The PPD Intelligence Bureau consists of multiple units that support the collection, analysis, and dissemination of intelligence for the PPD as well as all our regional, state, and federal partners. The units are the Real-Time Crime Center (RTCC), Criminal Intelligence Unit, Delaware Valley Intelligence Center and Analysis and Investigations. The RTCC serves as the regional watch center and operates 24/7 to receive all tips/leads for the Philadelphia region as well support request for information from regional law enforcement partners. The Delaware Valley Intelligence Center serves as the regional fusion center for the Philadelphia metropolitan area. The DVIC supports DHS programs to include SAR and TSC in addition to supporting local and nationwide requests for information, providing information sharing and producing analytic products related to local terrorism and criminal trends. Analysis and Investigations provides our intelligence and crime analysis component, focused on violent criminal activity in Philadelphia. The Criminal Intelligence Unit serves as our collection platform for human and open source intelligence. The benefit of this structure is the ability of these units to coordinate and collaborate daily in support of the Intelligence mission. The DVIC facility also houses our Homeland Security Bureau/Counter Terror Operations Unit, which allows us to immediately coordinate any information to the homeland security detectives for investigation.

The key personnel for this program are:

Daniel MacDonald, Chief Inspector Intelligence Bureau. Responsible for the management of the Intelligence Bureau which includes all the units and programs.

Tara Garvey, Ph.D., Deputy Director Intelligence Bureau. Responsible for the management of the Fusion Liaison Officer program.

Anthony Jackson, Police Officer, Criminal Intelligence Unit. Responsible for the collection of raw intelligence, outreach to the PPD district personnel and collaboration with the FBI on HVEs.

Intelligence Bureau personnel trained as FLO coordinators will provide training/outreach. In support of this program, additional police officers will be assigned to conduct outreach to PPD district patrol operations. This will allow for the increased outreach identified previously.

#### 4. Sustainability

The TVTP grant funding will allow the PPD Intelligence Bureau to expand the Fusion Liaison Program. The PPD Intelligence Bureau will maintain the training classes and outreach established through this grant program. The capabilities developed through this

grant will be sustained by the Philadelphia Police Department through personnel allocation and overtime.

# 5. Budget Detail and Narrative

The total budget to support expansion of the PPD Intelligence Bureau/DVIC Fusion Liaison Officer program is \$43,300. Most of the funding is to support Intelligence Bureau personnel providing training to all shifts on the indicators of targeted violence and terrorism. This training will reach to approximately 4,500 patrol personnel. The production of a training brochures to support the training will cost \$4,500.

#### Abstract:

The Philadelphia Police Department Intelligence Bureau Center has seen a significant increase in violent acts of domestic terrorism within the last several years. In response, the Intelligence Bureau has developed a section dedicated to focusing on domestic terrorist groups. These groups in Philadelphia include extremist groups at both the right and left side of the political spectrum as well as those motivated by entirely other agendas. The section remains vigilant to thwart the criminal efforts of these groups. The Intelligence Bureau is currently structured to handle collection of various types of intelligence and produce actionable intelligence. The key gaps in the program are awareness of the issues associated with domestic terrorism amongst our patrol operations, which is a force multiplier for intelligence collection as well as technology that can increase the reporting of tips/leads from the community and analytic platforms to produce a higher quantity and quality of actionable intelligence. Building these components into the domestic terrorism section will develop a program that can meet the goal of prevention of domestic terrorism.

#### 1. Needs Assessment

The Philadelphia Police Department Intelligence Bureau Center has seen a significant increase in violent acts of domestic terrorism within the last several years. In response, the Intelligence Bureau has a section dedicated to focusing on domestic terrorist groups. These groups in Philadelphia include extremist groups at both the right and left side of the political spectrum as well as those motivated by entirely other agendas. The section investigates both violence and serious property crimes that these groups leave in their wake in furtherance of their ideological goals. These goals vary considerably from hinderance of gentrification, to a failure to recognize government, to hate, but regardless of their ideology, the use of violence to achieve their goals defines their activity as terrorism. The section remains vigilant to thwart the criminal efforts of these groups, from the Proud Boys to the Sovereign Citizens to the anarchists and those in between the extremes.

Currently, the program relies on human source reporting as well as open source searching. Resource limitations have prevented the program from reaching its full potential. The current program requires a training/outreach component to provide awareness of the domestic terrorism groups and the associated tactics, techniques and procedures (TTPs) to patrol operations (approximately 4,500 patrol personnel) as well as the use of cutting edge technology to bring together the tips/leads, intelligence collection and analytic components of the program. The technology would directly support the work of the Domestic Terrorism section, but the effect would have a broader target audience in that the intelligence would be shared with patrol operations, Counter Terror Operation Unit detectives, FBI JTTF task force officers and analysts as well as the analytic products often have a regional distribution.

#### 2. Program Design

<u>Problem Statement:</u> The PPD Intelligence Bureau adapted its operations to focus on domestic terrorist groups in Philadelphia as their propensity for violence has emerged in recent years. The organizational structure of the PPD Intelligence Bureau allows for it to fully utilize the intelligence cycle to develop a high performing domestic terrorism program.

The framework for a comprehensive program exists. Specifically, the Intelligence Bureau has developed domestic terrorism intelligence requirements, collects various types of intelligence from human sources, open source and technical data, collates and stores the collected intelligence as Intelligence and Information Reports (IIRs) in the Intelligence Bureau's records management system, produces finished intelligence products and disseminates the actionable intelligence to operations personnel. Another

component of the domestic terrorism section is a strong collaboration with the PPD Counter Terrorism Unit as well as with the FBI JTTF task force officers and analysts.

In order to bring the program to the next level to meet the long term goal of prevention of terrorism, the program requires PPD patrol operations to have a widespread awareness of the tactics, techniques and procedures (TTPs) of the extremist groups. This can be accomplished by increasing training/outreach about domestic terrorism groups to PPD patrol operations using the Intelligence Bureau/DVIC Fusion Liaison Officer program. A significant increase in training/outreach to inform all patrol personnel should result in reporting of incidents to the Intelligence Bureau.

Technology platforms are the other key component to allow this program to meet our goals. The Tip411 platform will allow us not only to receive information from texts and social media apps to include pictures and video from the community, but will also allow us to directly message domestic terrorism issues to specific community leaders in areas of concern, resulting in increased reporting. Technology that will increase our data analytics capabilities is the final element to develop a program that will support the goal of violence prevention. Currently, our collection encompasses human source intelligence by our CIU collection and debriefing teams, open source searching, digital media evidence and tips/lead data. Technology such as Cell Hawk Analytics and PenLink will allow us to analyze phone call details records as well as digital media evidence collected through digital forensics exploitation and IP warrants. These two platforms alone would greatly enhance our ability to identify connections between people, places, and things in support of the domestic terrorism program.

#### Program goals and objectives:

Goals: The goal of this program would be to prevent violence associated with the entire spectrum of domestic terrorist groups within Philadelphia. This prevention would be accomplished through integration of additional key components to the domestic terrorism section's operations, resulting in increased intelligence collection and analysis. First, performing significant amounts of outreach to the PPD patrol operations focused on the TTPs of the specific domestic terrorist groups operating in Philadelphia will result in increased reporting of incidents. Second, incorporating technology that allows for increased collection and analytic capabilities. Third, as the intelligence collection types and quantity increases as well as the ability to analyze various types of data with improved technologies, solid actionable intelligence can be generated to thwart these groups.

### Objectives:

- 1- Perform 130 outreach to Philadelphia Police Department patrol operations utilizing the Fusion Liaison Officer Program Coordinators. The focus of the outreach will be domestic terrorism TTPs for Philadelphia groups.
- 2- Provide pre- and post- training surveys to determine effectiveness of outreach in terms of knowledge gained about the domestic terrorism TTPs for Philadelphia groups.
- 3- Produce analytic products that provide awareness to potentially violent activities as well as describe the TTPs for the domestic terrorist groups in Philadelphia. A minimum of 20 products per year will be produced.
- 4- Increase the production of Intelligence and Information Reports (IIRs) by 25% by the end of the period of performance.
- 5- Increase the receipt of tips and leads on domestic terrorism by 25% by the end of the period of performance.
- 6- Utilize analytic technology to include Tip411, Cell Hawk Analytics and PenLink to gather information and analyze the information to produce actionable intelligence. Disseminate this intelligence to patrol operations, Counter Terror Operations Unit, and the FBI. Increase support to investigations by 25% by the end of the period of performance.

### Logic Model

Theory of Change: The changes described in the logic model are expected to occur based on previous experience within the Intelligence Bureau, utilizing the full capacity of the intelligence cycle results in prevention of violent crime. Combine this with the proposed technology additions and outreach, the results should be to increase our ability to prevent acts of violence and vandalism by domestic terrorist groups within Philadelphia.

Intelligence Bureau personnel trained as FLO coordinators will provide the outreach. In support of this program, additional police officers will be assigned to conduct outreach to PPD district patrol operations on the TTPS for domestic terrorist groups. This will support the increased outreach identified in this proposal.

#### 4. Sustainability

The capabilities of the funded through this grant program will integrated into the Intelligence Bureau's standard operating procedures and will be sustained by the Philadelphia Police Department operating budget.

#### 5. Budget Detail and Narrative

The total budget to develop necessary capabilities for the PPD Intelligence Bureau Domestic Terrorism Program is \$241,300 with \$43,300 for training and \$198,000 for technology platforms to increase our collection and analytic capabilities.

The budget for outreach encompasses funding to support training on all 3 shifts as well as the purchase of brochures. The budget for technology platforms will allow us to increase our ability to receive tips/leads as well as communicate with the community and provide analytic capabilities as it relates to information collected through electronic means.

Tip411 is a tips/leads platform that allows us to receive tips to include pictures and video from social media applications as well as texts and provides for the ability to have 2-way communication. In addition, the platform provides the ability to reach the community with specific messaging relevant to their area of the city. The funding will provide for 2 years of service.

PenLink provides for the analysis of data obtained through digital forensic exploitation and IP warrants allowing the analyst to make connections between people, places, and

things. The platform will support open source collectors, human source collectors and analysts to develop better actionable intelligence. The funding will provide for 10 licenses.

Cell Hawk Analytics provides for the analysis of phone records. This funding will support 10 licenses for 2 years.

#### Abstract:

The Philadelphia Police Department Intelligence Bureau/Delaware Valley Intelligence Center (DVIC) has an established Fusion Liaison Officer program that promotes the collection of suspicious activity reporting and other criminal activity through a combination of basic and specialized training classes and outreach. Currently, the FLO program has approximately 150 FLOs, which comprises every patrol district, detective division and special unit within the PPD and regional law enforcement agencies as well as private sector personnel from the Philadelphia metropolitan area. The PPD officers and private sector personnel are our force multiplier in the collection of information related to targeted violence and terrorism. The Intelligence Bureau wants to expand this program. Specifically, the content of the current training will be expanded to include a focus on violent extremism indicators as well as the behavioral indicators of targeted violence. The expansion of the program would also include significantly increasing the number of trainings, specifically outreach to all personnel in the PPD patrol districts. These program enhancements should increase awareness of the targeted violence and terrorism indicators and result in increased reporting and prevention of this type of violence in the Philadelphia.

#### 1. Needs Assessment

The Philadelphia Police Department Intelligence Bureau/Delaware Valley Intelligence Center (DVIC) has an established Fusion Liaison Officer program that promotes the collection of suspicious activity reporting and other criminal activity through a combination of basic and specialized training classes and outreach. The program also provides Privacy Civil Rights and Liberties training. Currently, the FLO program has approximately 150 FLOs, which comprises every patrol district, detective division and special unit within the PPD and regional law enforcement agencies as well as private sector personnel from the Philadelphia metropolitan area. The Intelligence Bureau wants to expand this program, which will require additional resources for training, outreach, and training materials. Specifically, the PPD officers are our force multiplier in the collection of information related to targeted violence and terrorism on the streets. During the period of performance, the training content would be expanded to include a focus on violent extremism indicators with specific local examples as well as the behavioral indicators of targeted violence. Second, the number of training would be expanded with a specific focus on outreach to all personnel in the patrol districts (approximately 4,500 personnel). This will require additional resources to employ the use of Intelligence Bureau personnel for additional hours to support training on all three shifts. Providing training and outreach to all the patrol officers should increase awareness of the targeted violence and terrorism indicators and result in increased reporting to the Intelligence Bureau. The increased outreach should fill the gap of having limited personnel trained within the PPD with the goal of providing training to the over four thousand PPD patrol officers and supervisors.

#### 2. Program Design

<u>Problem Statement:</u> The PPD Intelligence Bureau would like to increase the collection of information and intelligence related to targeted violence and terrorism through the expansion of PPD Intelligence Bureau/DVIC Fusion Liaison Officer Program. The collection and analysis of this intelligence will increase the safety of the Philadelphia metropolitan area.

Currently, the Fusion Liaison Officer program has trained several local and regional law enforcement and private sector personnel with a focus on terrorism prevention. The program requires enhanced curriculum to include indicators of targeted violence, additional training classes and a significant increase in outreach. In order to bring the program to the next level, the Intelligence Bureau requires funding to support the purchase of training materials and additional work hours needed for our FLO coordinators to provide training/outreach on all shifts to reach the maximum number of officers. The key to the increased collection and reporting of potential acts of violence is training many officers. Through community policing, the officers will reach out to

community leaders, faith-based leaders, and others within their area of responsibility to build relationships to further increase the reporting of potential threats of violence.

#### Program goals and objectives:

<u>Goals:</u> The goal of the program is to train Philadelphia regional law enforcement and private sector personnel on the indicators of targeted violence and terrorism. Specifically, provide training and outreach to the majority of PPD patrol personnel on the indicators of targeted violence and terrorism as well as specific issues related to these topics in Philadelphia. The enhanced topics and increased training should result in increased reporting of information related to potential threats of violence to the PPD Intelligence Bureau and therefore, result in prevention such acts within the region.

#### Objectives:

- 1- The program will perform ten training classes to include PPD and regional law enforcement. This will train approximately 250 fusion liaison officers.
- 2- The program will conduct 130 outreaches to the Philadelphia Police Department patrol operations.
- 3- The program will conduct five training classes to the private sector. This will train approximately 125 private sector partners.
- 4- Provide pre- and post- training surveys to determine effectiveness of training in terms of knowledge gained about indicators of targeted violence and terrorism.

# Logic Model

Theory of Change: The changes described in the logic model are expected to occur because based on previous experience with the existing program, performing outreach, networking with the officers and following up with them on a regular basis has resulted in an increase in reporting of information related to potential terrorism incidents. Based on the proposed program changes to include additional indicators of targeted violence and terrorism and to significantly increase the training classes and outreach, the reporting of potential violence to the Intelligence Bureau should increase and thereby result in the prevention of violence in the Philadelphia Metropolitan Regions.

# 3. Organization and Key Personnel

The PPD Intelligence Bureau consists of multiple units that support the collection, analysis, and dissemination of intelligence for the PPD as well as all our regional, state, and federal partners. The units are the Real-Time Crime Center (RTCC), Criminal Intelligence Unit, Delaware Valley Intelligence Center and Analysis and Investigations. The RTCC serves as the regional watch center and operates 24/7 to receive all tips/leads for the Philadelphia region as well support request for information from regional law enforcement partners. The Delaware Valley Intelligence Center serves as the regional fusion center for the Philadelphia metropolitan area. The DVIC supports DHS programs to include SAR and TSC in addition to supporting local and nationwide requests for information, providing information sharing and producing analytic products related to local terrorism and criminal trends. Analysis and Investigations provides our intelligence and crime analysis component, focused on violent criminal activity in Philadelphia. The Criminal Intelligence Unit serves as our collection platform for human and open source intelligence. The benefit of this structure is the ability of these units to coordinate and collaborate daily in support of the Intelligence mission. The DVIC facility also houses our Homeland Security Bureau/Counter Terror Operations Unit, which allows us to immediately coordinate any information to the homeland security detectives for investigation.

The key personnel for this program are:

Daniel MacDonald, Chief Inspector Intelligence Bureau. Responsible for the management of the Intelligence Bureau which includes all the units and programs.

Tara Garvey, Ph.D., Deputy Director Intelligence Bureau. Responsible for the management of the Fusion Liaison Officer program.

Anthony Jackson, Police Officer, Criminal Intelligence Unit. Responsible for the collection of raw intelligence, outreach to the PPD district personnel and collaboration with FBI on Domestic Extremists and Homegrown Violent Extremists.

Intelligence Bureau personnel trained as FLO coordinators will provide training/outreach. In support of this program, additional police officers will be assigned to conduct outreach to PPD district patrol operations. This will allow for the increased outreach identified previously.

#### 4. Sustainability

The TVTP grant funding will allow the PPD Intelligence Bureau to expand the Fusion Liaison Program. The PPD Intelligence Bureau will maintain the training classes and outreach established through this grant program. The capabilities developed through this grant will be sustained by the Philadelphia Police Department through personnel allocation and overtime.

# 5. Budget Detail and Narrative

The total budget to support expansion of the PPD Intelligence Bureau/DVIC Fusion Liaison Officer program is \$43,300. Most of the funding is to support Intelligence Bureau personnel providing training to all shifts on the indicators of targeted violence and terrorism. This training will reach to approximately 4,500 patrol personnel. The production of a training brochures to support the training will cost \$4,500.

#### Abstract:

The Philadelphia Police Department Intelligence Bureau Center has seen a significant increase in violent acts of domestic terrorism within the last several years. In response, the Intelligence Bureau has developed a section dedicated to focusing on domestic terrorist groups. These groups in Philadelphia include extremist groups at both the right and left side of the political spectrum as well as those motivated by entirely other agendas. The section remains vigilant to thwart the criminal efforts of these groups. The Intelligence Bureau is currently structured to handle collection of various types of intelligence and produce actionable intelligence. The key gaps in the program are awareness of the issues associated with domestic terrorism amongst our patrol operations, which is a force multiplier for intelligence collection as well as technology that can increase the reporting of tips/leads from the community and analytic platforms to produce a higher quantity and quality of actionable intelligence. Building these components into the domestic terrorism section will develop a program that can meet the goal of prevention of domestic terrorism.

#### 1. Needs Assessment

The Philadelphia Police Department Intelligence Bureau Center has seen a significant increase in violent acts of domestic terrorism within the last several years. In response, the Intelligence Bureau has a section dedicated to focusing on domestic terrorist groups. These groups in Philadelphia include extremist groups at both the right and left side of the political spectrum as well as those motivated by entirely other agendas. The section investigates both violence and serious property crimes that these groups leave in their wake in furtherance of their ideological goals. These goals vary considerably from hinderance of gentrification, to a failure to recognize government, to hate, but regardless of their ideology, the use of violence to achieve their goals defines their activity as terrorism. The section remains vigilant to thwart the criminal efforts of these groups, from the Proud Boys to the Sovereign Citizens to the anarchists and those in between the extremes.

Currently, the program relies on human source reporting as well as open source searching. Resource limitations have prevented the program from reaching its full potential. The current program requires a training/outreach component to provide awareness of the domestic terrorism groups and the associated tactics, techniques and procedures (TTPs) to patrol operations (approximately 4,500 patrol personnel) as well as the use of cutting edge technology to bring together the tips/leads, intelligence collection and analytic components of the program. The technology would directly support the work of the Domestic Terrorism section, but the effect would have a broader target audience in that the intelligence would be shared with patrol operations, Counter Terror Operation Unit detectives, FBI JTTF task force officers and analysts as well as the analytic products often have a regional distribution.

# 2. Program Design

<u>Problem Statement:</u> The PPD Intelligence Bureau adapted its operations to focus on domestic terrorist groups in Philadelphia as their propensity for violence has emerged in recent years. The organizational structure of the PPD Intelligence Bureau allows for it to fully utilize the intelligence cycle to develop a high performing domestic terrorism program.

The framework for a comprehensive program exists. Specifically, the Intelligence Bureau has developed domestic terrorism intelligence requirements, collects various types of intelligence from human sources, open source and technical data, collates and stores the collected intelligence as Intelligence and Information Reports (IIRs) in the Intelligence Bureau's records management system, produces finished intelligence products and disseminates the actionable intelligence to operations personnel. Another

component of the domestic terrorism section is a strong collaboration with the PPD Counter Terrorism Unit as well as with the FBI JTTF task force officers and analysts.

In order to bring the program to the next level to meet the long term goal of prevention of terrorism, the program requires PPD patrol operations to have a widespread awareness of the tactics, techniques and procedures (TTPs) of the extremist groups. This can be accomplished by increasing training/outreach about domestic terrorism groups to PPD patrol operations using the Intelligence Bureau/DVIC Fusion Liaison Officer program. A significant increase in training/outreach to inform all patrol personnel should result in reporting of incidents to the Intelligence Bureau.

Technology platforms are the other key component to allow this program to meet our goals. The Tip411 platform will allow us not only to receive information from texts and social media apps to include pictures and video from the community, but will also allow us to directly message domestic terrorism issues to specific community leaders in areas of concern, resulting in increased reporting. Technology that will increase our data analytics capabilities is the final element to develop a program that will support the goal of violence prevention. Currently, our collection encompasses human source intelligence by our CIU collection and debriefing teams, open source searching, digital media evidence and tips/lead data. Technology such as Cell Hawk Analytics and PenLink will allow us to analyze phone call details records as well as digital media evidence collected through digital forensics exploitation and IP warrants. These two platforms alone would greatly enhance our ability to identify connections between people, places, and things in support of the domestic terrorism program.

## Program goals and objectives:

Goals: The goal of this program would be to prevent violence associated with the entire spectrum of domestic terrorist groups within Philadelphia. This prevention would be accomplished through integration of additional key components to the domestic terrorism section's operations, resulting in increased intelligence collection and analysis. First, performing significant amounts of outreach to the PPD patrol operations focused on the TTPs of the specific domestic terrorist groups operating in Philadelphia will result in increased reporting of incidents. Second, incorporating technology that allows for increased collection and analytic capabilities. Third, as the intelligence collection types and quantity increases as well as the ability to analyze various types of data with improved technologies, solid actionable intelligence can be generated to thwart these groups.

# Objectives:

- 1- Perform 130 outreach to Philadelphia Police Department patrol operations utilizing the Fusion Liaison Officer Program Coordinators. The focus of the outreach will be domestic terrorism TTPs for Philadelphia groups.
- 2- Provide pre- and post- training surveys to determine effectiveness of outreach in terms of knowledge gained about the domestic terrorism TTPs for Philadelphia groups.
- 3- Produce analytic products that provide awareness to potentially violent activities as well as describe the TTPs for the domestic terrorist groups in Philadelphia. A minimum of 20 products per year will be produced.
- 4- Increase the production of Intelligence and Information Reports (IIRs) by 25% by the end of the period of performance.
- 5- Increase the receipt of tips and leads on domestic terrorism by 25% by the end of the period of performance.
- 6- Utilize analytic technology to include Tip411, Cell Hawk Analytics and PenLink to gather information and analyze the information to produce actionable intelligence. Disseminate this intelligence to patrol operations, Counter Terror Operations Unit, and the FBI. Increase support to investigations by 25% by the end of the period of performance.

# Logic Model

Theory of Change: The changes described in the logic model are expected to occur based on previous experience within the Intelligence Bureau, utilizing the full capacity of the intelligence cycle results in prevention of violent crime. # 3. Organization and Key Personnel

The PPD Intelligence Bureau consists of multiple units that support the collection, analysis, and dissemination of intelligence for the PPD as well as all our regional, state, and federal partners. The units are the Real-Time Crime Center (RTCC), Criminal Intelligence Unit, Delaware Valley Intelligence Center and Analysis and Investigations. The RTCC serves as the regional watch center and operates 24/7 to receive all tips/leads for the Philadelphia Metropolitan regions as well support request for information from regional law enforcement partners. The Delaware Valley Intelligence Center serves as the regional fusion center for the Philadelphia Metropolitan Area. The DVIC supports DHS programs to include SAR and TSC in addition to supporting local and nationwide requests for information, providing information sharing and producing analytic products related to local terrorism and criminal trends. Analysis and Investigations provides our intelligence and crime analysis component, focused on violent criminal activity in Philadelphia. The Criminal Intelligence Unit serves as our collection platform for human source and open source intelligence. The benefit of this structure is the ability of these units to coordinate and collaborate daily in support of the Intelligence mission. The DVIC facility also houses our Homeland Security Bureau/Counter Terror Operations Unit, which allows us to immediately coordinate any information to the homeland security detectives for investigation.

The key personnel for this program are:

Daniel MacDonald, Chief Inspector Intelligence Bureau. Responsible for the management of the Intelligence Bureau which includes all the units and programs.

Tara Garvey, Ph.D., Deputy Director Intelligence Bureau. Responsible for the management of the Fusion Liaison Officer program.

Michael McCarrick, Inspector Intelligence Bureau/Director DVIC. Responsible for the management of the Units responsible for the collection and analysis of domestic terrorism information and intelligence.

Robert Heinzeroth, Captain Criminal Intelligence Unit. Management of the Unit responsible for the collection of domestic terrorism information and intelligence.

John McDonald, Lieutenant Criminal Intelligence Unit. Management of the section responsible for the collection of domestic terrorism information and intelligence.

James Muller, Lieutenant Criminal Intelligence Unit, Collection Manager. Responsible for managing the collection of all intelligence for the Intelligence Bureau and determining gaps in our collection.

Ernest Hall, Sergeant Criminal Intelligence Unit. Supervises the section responsible for the collection of domestic terrorism information and intelligence.

Heaven Henwood, Law Enforcement Analyst Supervisor, Delaware Valley Intelligence Center Unit. Responsible for the production of analytic products based on the collection of information from the domestic terrorism section.

Alfred Hindley, Police Officer, Criminal Intelligence Unit. Collection, evaluation and dissemination of information and intelligence on the tactics and modes of operation of domestic extremist groups in Philadelphia.

James O'Neill, Police Officer, Criminal Intelligence Unit. Collection, evaluation and dissemination of information and intelligence on the tactics and modes of operation of domestic extremist groups in Philadelphia.

Harry Wenger, Police Officer, Criminal Intelligence Unit. Collection, evaluation and dissemination of information and intelligence on the tactics and modes of operation of domestic extremist groups in Philadelphia.

Anthony Jackson, Police Officer, Criminal Intelligence Unit. Responsible for the collection of raw intelligence, outreach to the PPD district personnel and collaboration with FBI on Domestic Extremists and Homegrown Violent Extremists.

Intelligence Bureau personnel trained as FLO coordinators will provide the outreach. In support of this program, additional police officers will be assigned to conduct outreach to PPD district patrol operations on the TTPS for domestic terrorist groups. This will support the increased outreach identified in this proposal.

# 4. Sustainability

The capabilities of the funded through this grant program will integrated into the Intelligence Bureau's standard operating procedures and will be sustained by the Philadelphia Police Department operating budget.

# 5. Budget Detail and Narrative

The total budget to develop necessary capabilities for the PPD Intelligence Bureau Domestic Terrorism Program is \$241,300 with \$43,300 for training and \$198,000 for technology platforms to increase our collection and analytic capabilities.

The budget for outreach encompasses funding to support training on all 3 shifts as well as the purchase of brochures. The budget for technology platforms will allow us to increase our ability to receive tips/leads as well as communicate with the community and provide analytic capabilities as it relates to information collected through electronic means.

Tip411 is a tips/leads platform that allows us to receive tips to include pictures and video from social media applications as well as texts and provides for the ability to have 2-way communication. In addition, the platform provides the ability to reach the community with specific messaging relevant to their area of the city. The funding will provide for 2 years of service.

PenLink provides for the analysis of data obtained through digital forensic exploitation and IP warrants allowing the analyst to make connections between people, places, and things. The platform will support open source collectors, human source collectors and analysts to develop better actionable intelligence. The funding will provide for 10 licenses.

Cell Hawk Analytics provides for the analysis of phone records. This funding will support 10 licenses for 2 years.




