Primary Responsibility Rests with State and Local Governments

State and local governmental public health agencies have primary responsibility and authority for public health response to biological incidents within their jurisdictions and can implement quarantine and movement restrictions that can vary, based in part, from federal guidance issued by the Centers

for Disease Control and Prevention (CDC). [1]

Federal Doctrine and Policy Places HHS in the Lead at the Federal Level

During a Federal biological incident response – inclusive of naturally occurring and intentional acts – the U.S. Department of Health and Human Services (HHS) is responsible for coordinating the Federal Government's response in support of the affected state, local, tribal, and territorial officials. Other Federal departments and agencies will perform roles and responsibilities congruent with their statutory authority in coordination with HHS as lead federal agency. The White House National

Security Council Staff provides policy coordination and deconfliction, as required.

HHS has an emergency fund (the Public Health Emergency Fund or PHEF) that has historically not been funded by Congress and has often required Supplemental Appropriations to fund emergency response to outbreaks.

FEMA Can Support HHS and Others with Incident Management and Coordination Capabilities

FEMA can support HHS as the Lead Federal Agency through the Economy Act under Inter-Agency Agreements (IAA). Types of assistance offered to HHS in the past have included:

- • perational coordination
- • perational communications
- • Planning and Situational Awareness
- • Public information
- • Logistics and supply chain management

Even without a Stafford Act declaration, FEMA could be asked to assist coordinating inter-agency response. The Pandemic Crisis Action Plan (or PanCAP) is a document that was updated most recently in 2018. It describes a graduated response to a pandemic in which the Lead Federal Agency can require increasing amounts of assistance as the incident dictates and higher levels of inter-agency

coordination occur throughout increased threat levels. This is consistent with the broader policy document, the Biologic Incident Annex or BIA, which was approved by the NSC in 2017.

FEMA Can Support State and Local Governments Under the Stafford Act, but there is Extremely Limited Precedent

FEMA has developed guidance on the scope of assistance that may be provided under an Emergency Declaration for an infectious disease incident (see attachment), but there is extremely limited precedent for taking this step. The Stafford Act has been used only for response to one biological incident, when President Clinton approved Emergency Declarations to provide very limited Public Assistance to compensate for vector control during initial West Nile identification in New York and [4]

New Jersey.

It is difficult to predict potential state, local, tribal, and territorial (SLTT) requests for Federal assistance, but they will most likely encompass:

- • Funding for the SLTT public health response
- • Supplies (e.g. PPE, medications, vaccine development)
- • Information (mainly from HHS) regarding guidance, recommendations, etc.
- • Assistance with the implementation of non-pharmaceutical interventions (NPIs such as school closures)
- • Support in training or coordinating operations among Emergency Management and Public Health disciplines

Inherent Public Health operations authorized through HHS, such as vaccine development, do not qualify for Stafford Act assistance.

INFECTIOUS DISEASE EVENT

This Fact Sheet describes the scope of assistance that may be provided under a Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) emergency declaration in response to a domestic infectious disease event. Any action taken by the Department of Homeland Security (DHS), including the Federal Emergency Management Agency (FEMA), in response to an infectious disease event will be within the context of an integrated whole community all hazards approach and in coordination with other agency authorities and activities that would have a primary role in these incidents, including the U.S. Department of Health and Human Services (HHS) and its Centers for Disease Control and Prevention (CDC). In order to assist States, Tribes and U.S. Territories in assessing impacts and evaluating the need for Federal assistance in an infectious disease event, FEMA has developed these guidelines for requesting an emergency declaration.

As part of an all hazards approach, the key roles and responsibilities across the whole community for any threat or hazard – including infectious disease – are contained in the national planning frameworks for prevention, protection, mitigation, response, and recovery. Supporting federal interagency operational plans (FIOPs) include a more detailed concept of operations; description of critical tasks and responsibilities; detailed resource, personnel, and sourcing requirements; and specific provisions for the rapid integration of resources and personnel appropriate for responding to Public Health events.

Emergency Declaration

- Other federal agencies, such as HHS and its CDC have existing authorities that enable support and assistance for the State or Tribe in an infectious disease event.
- For the purpose of emergency declarations for an infectious disease event, FEMA will follow the procedures described in 44 C.F.R. § 206.35, Requests for Emergency Declarations. As with all declaration requests, FEMA utilizes a variety of evaluation criteria and factors, as established in 44 C.F.R. Part 206, Subpart B. However, the four primary evaluation criteria for an infectious disease emergency declaration are:

- Whether the State, Tribe or U.S. Territory has directed execution of its State/Tribe/U.S. Territory emergency plan; and
- Whether the State, Tribe or U.S. Territory has demonstrated that the incidence of infection for the event for which a declaration is being requested is significantly higher than the State's, Tribe's or U.S. Territory's baseline or is otherwise abnormally high enough to qualify the event for an emergency declaration; and
- Whether the State, Tribe or U.S. Territory can demonstrate that effective response to the event is beyond the capability of the State, Tribe, U.S. Territory, and/or affected local governments; and
- Whether the State, Tribe or U.S. Territory has identified specific, supplemental Federal emergency assistance that is required to save lives, protect public health and safety, or lessen or avert the threat of a disaster.
- FEMA will formulate a recommendation based on all available information to include whether Public Assistance Emergency Protective Measures (Category B), Direct Federal Assistance (e.g., personnel, equipment, and supplies) is needed to meet critical emergency protective requirements that are beyond the capability or capacity of the State, Tribe and/or U.S. Territory.
- FEMA may not duplicate assistance provided or available under the authority of another federal agency or from insurance. Other federal agencies, including but not limited to HHS and its CDC, have authority to provide assistance to support jurisdictions during infectious disease events.
- In the event of an emergency declaration, FEMA would determine the incident period in coordination with HHS.
- The President retains sole authority to approve all declaration requests, regardless of any FEMA recommendation.

Eligible Assistance

- Under an emergency declaration as described above, FEMA may provide assistance for emergency protective measures in accordance with Public Assistance policies and guidance. Assistance may include, but is not limited to the following:
 - Management, control and reduction of immediate threats to public health and safety:
 - Emergency Operation Centers (EOC) costs.
 - Training specific to the declared event.

- Decontaminating eligible public facilities, to include emergency responder vehicles.
- Decontaminating private facilities, such as infected person's residences, when determined necessary by the CDC, State, Tribe, U.S. Territory or local public health authorities.
- Technical assistance to State, Tribe, U.S. Territory and/or local governments on disaster management and control.
- Emergency medical care in accordance with FEMA Policy 9525.4 *Emergency Medical Care and Medical Evacuations*:
 - Non-deferrable medical treatment of infected persons in a shelter or temporary medical facility.
 - Related medical facility services and supplies, including x-rays, laboratory and pathology services, and machine diagnostic tests.
 - Temporary medical facilities (for treatment when existing facilities are overloaded and cannot accommodate the patient load or to quarantine potentially infected persons).
 - Inoculation for emergency responders.
 - Use of specialized medical equipment.
 - Medical waste disposal.
 - Emergency medical transport.
- Tracking potentially exposed persons.
- Congregate sheltering (when existing facilities are overloaded and cannot accommodate needs).
- Non-congregate sheltering, such as hotels, dormitories, etc. for the specific purpose of containment.
- Household Pet Sheltering in accordance with FEMA Policy 9523.19 *Eligible Costs Related to Pet Evacuations and Sheltering.*
- Containment actions related to household pets in accordance with CDC guidelines.
- Purchase and distribution of food, water, ice, medicine, and other consumable supplies, to include personal protective equipment (PPE) and hazardous material (HAZMAT) suits.
- Movement of supplies and persons.
- Security, to include barricade, fencing and law enforcement.
- Communicating health and safety information to the public.
- Protection of municipal water supply.
- Search and rescue to locate and recover members of the population requiring assistance, and to locate and recover human remains.
- Storage and interment of unidentified human remains.
- Mass mortuary services.
- Recovery and disposal of animal carcasses (except if another Federal authority funds the activity; e.g., U.S. Department of Agriculture – Animal and Plant Health Inspection Service provides for removal and disposal of livestock). See FEMA Recovery Fact Sheet 9580.206 Animal Carcass Removal and Disposal for additional information.

- Reimbursement for State, Tribe, U.S. Territory and/or local employees is limited to overtime. See 44 C.F.R. §206.228 for additional information.
- Donated Resources may be credited toward the non-federal cost share in accordance with FEMA Recovery Policy 9525.2 *Donated Resources*.
- Direct Federal assistance may be available through mission assignments (see Attachment), internal FEMA capabilities, or a combination of the two.

The PanCAP aligns CDC intervals with traditional emergency management response phases (e.g., elevated threat, credible threat), outlining graduated response activities for HHS and interagency partners with defined triggers for movement between phases. The PanCAP also provides a sample coordination structure for each phase, which has been adapted for the emerging novel corona virus (nCoV) by the Planning Cell (FEMA, ASPR, CDC).




Departmental Activities Outlined in the PanCAP

Department of Homeland Security (DHS) – Chief Medical OfficerServes as the Department's primary point of contact with HHS and other federal departments or agencies on medical and public health issues.DHS – Federal Emergency Management Agency (FEMA)Supports HHS requests for interagency planning and coordination through ESF #5 and under PPD-44.Reports the status of National Essential Functions to the White House in accordance with PPD-40.If the President invokes the Stafford Act, FEMA will coordinate federal support for consequence management through the National Response Coordination Center.DHS – Federal Protective Service (FPS)Provides personnel to RRCC and/or NRCC to perform duties of ESF #13 – Public Safety and Security in support of pre- or post-declaration support.DHS – National Operations Center (NOC)Serves as the primary nationallevel hub for domestic situational awareness, common operating picture, information fusion, information sharing, communications and strategic-level operations coordination.Maintains situational awareness and the common operating picture via the Homeland Security Information Network.

Pandemic Crisis Action Plan Coordination Structure

As the LFA for the federal public health and medical response, HHS makes the initial determination that interagency coordination beyond day-to-day processes is required. The interagency coordination structure, including participants, organization, and location (e.g. virtual or assembled) will be identified by HHS. As the threat evolves, the coordination construct, location, and participants may similarly evolve to address interagency coordination challenges. An example coordination structure that might be used during a pandemic is shown right.
