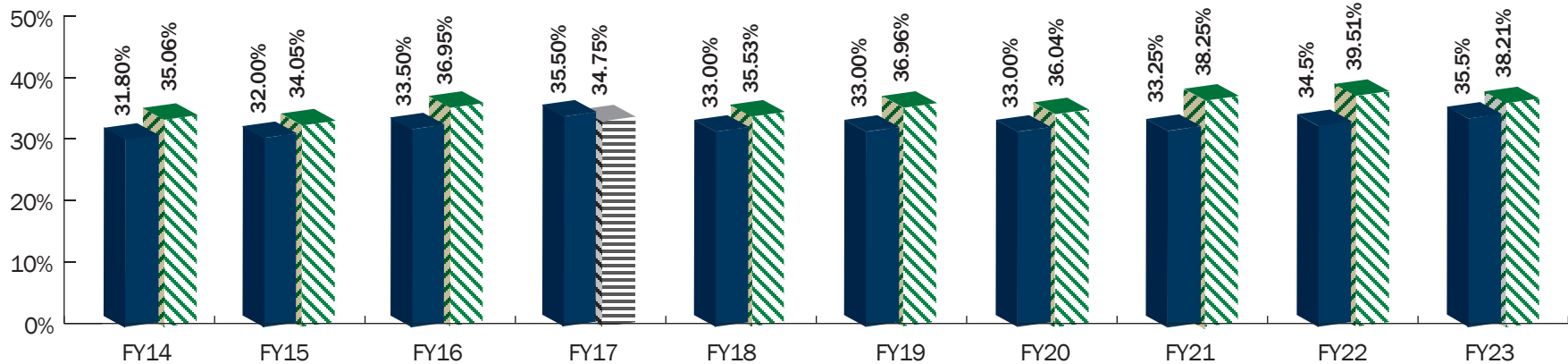
## Total Small Business (SB) Achievements

Since inception, DHS has made a commitment to small business inclusion in our contracting program. To implement the program, OSDBU works closely with the Office of the Chief Procurement Officer, the Heads of Contracting Activities, and the Component Small Business Specialists to ensure there are set-aside opportunities for small businesses.

Each fiscal year, the DHS OSDBU negotiates with the U.S. Small Business Administration (SBA) to establish small business prime contracting and subcontracting goals.

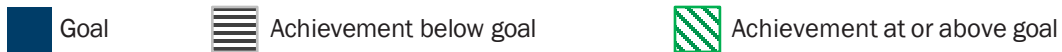
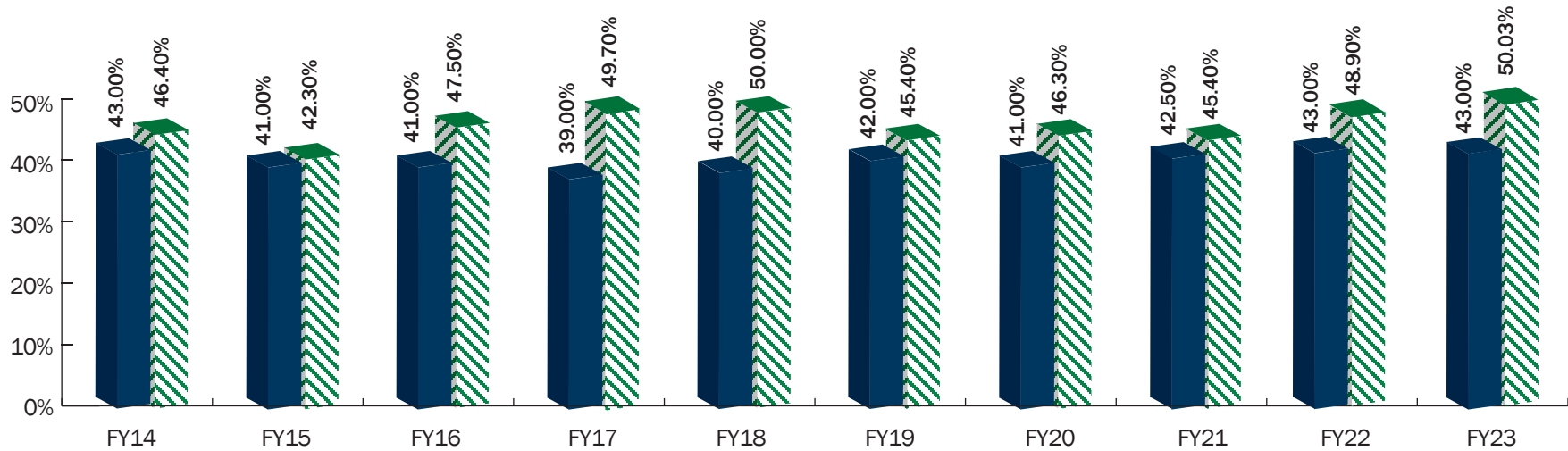
## SB Prime Contracting Achievements

The chart below provides the SB subcontracting goals and achievements for FY 2014–2023.



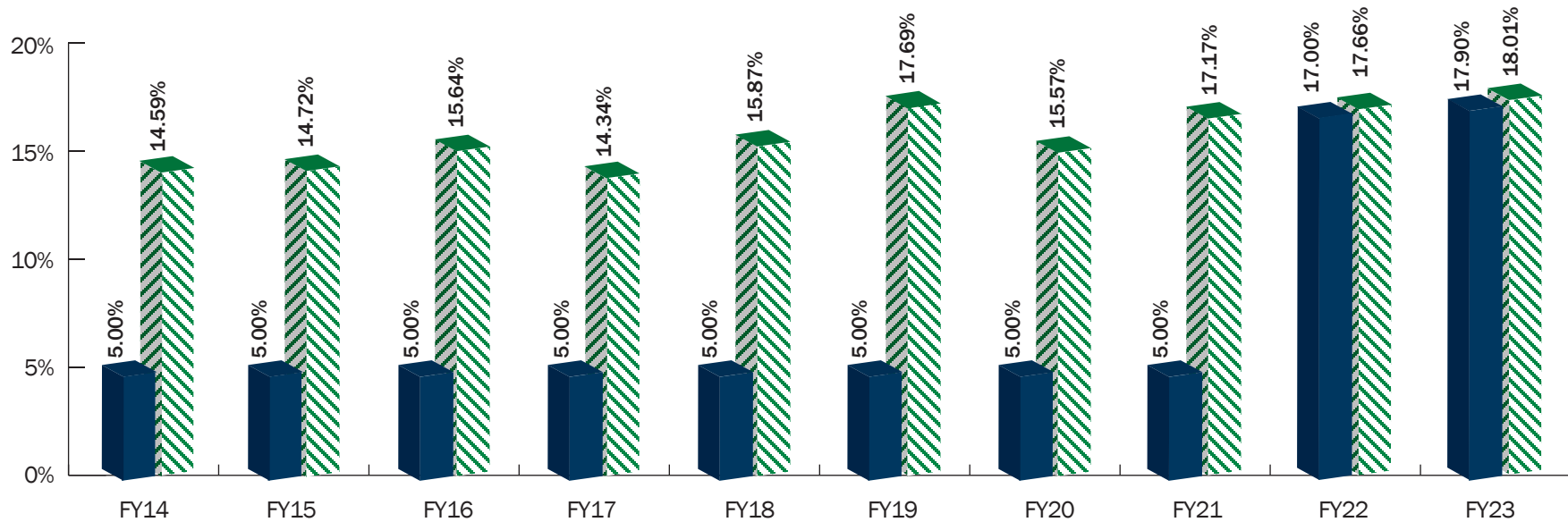
## Small Disadvantaged Business (SDB) Achievements

The chart below provides the SDB prime contracting achievements for FY 2014–2023.

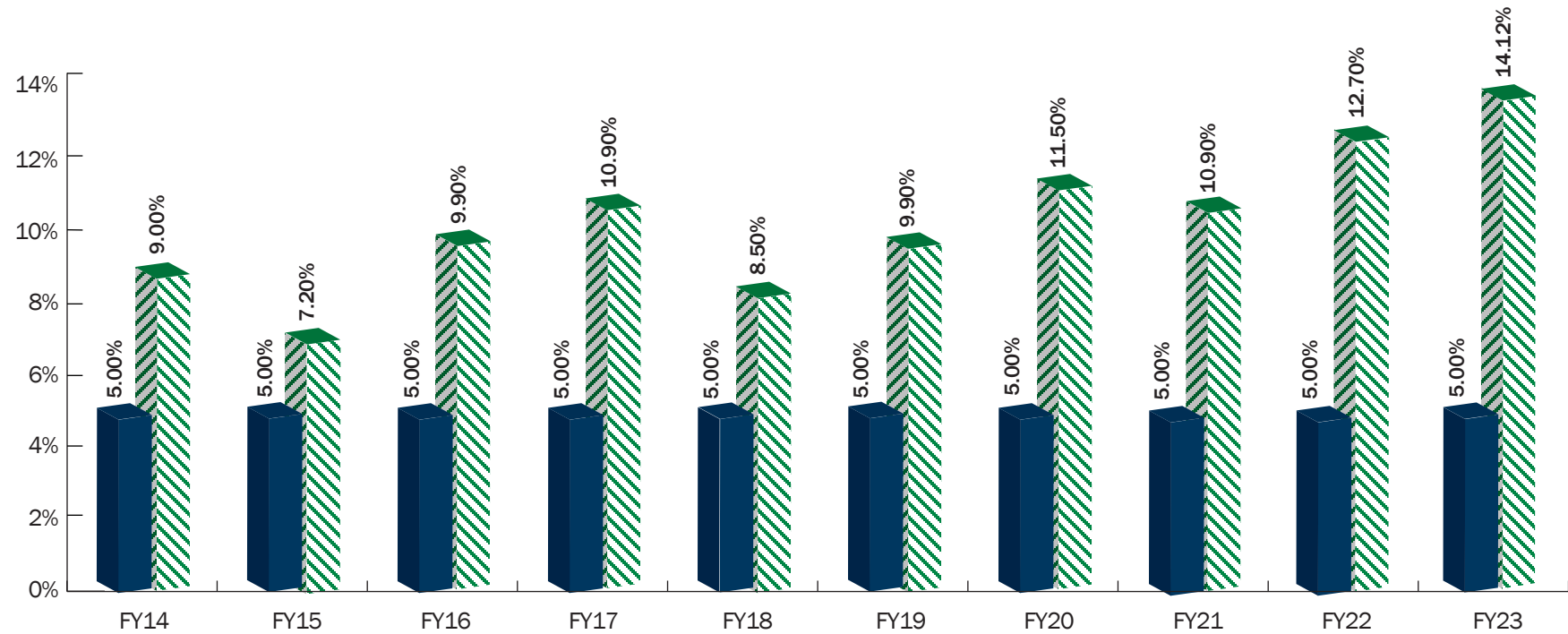

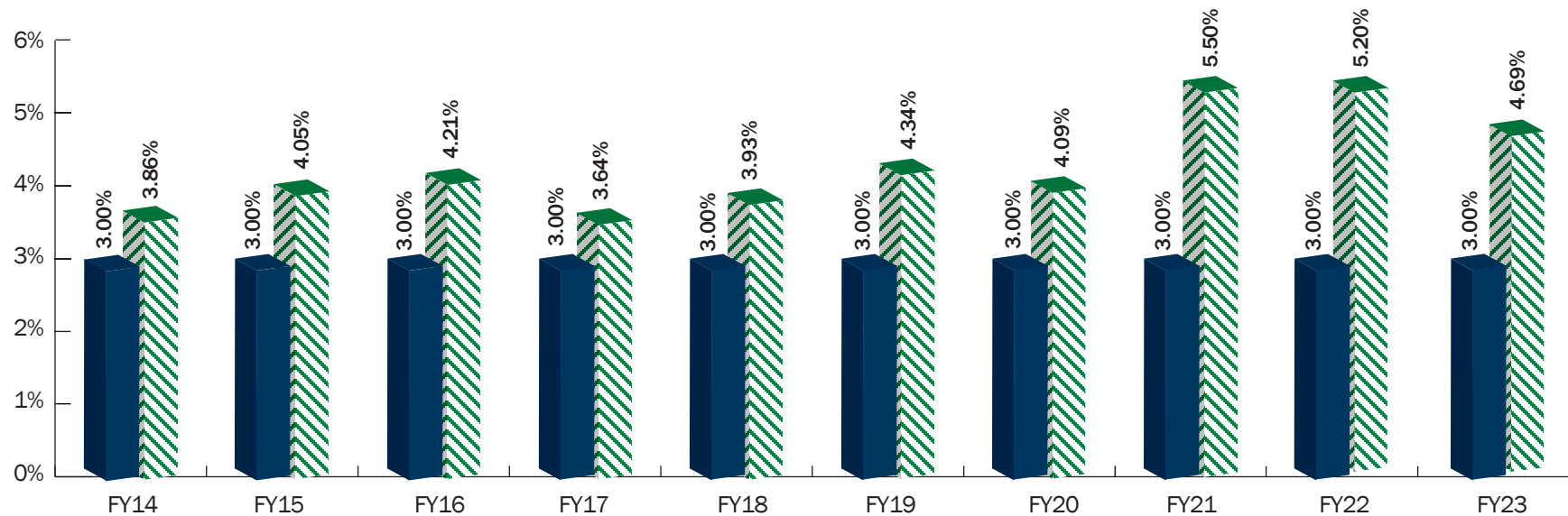

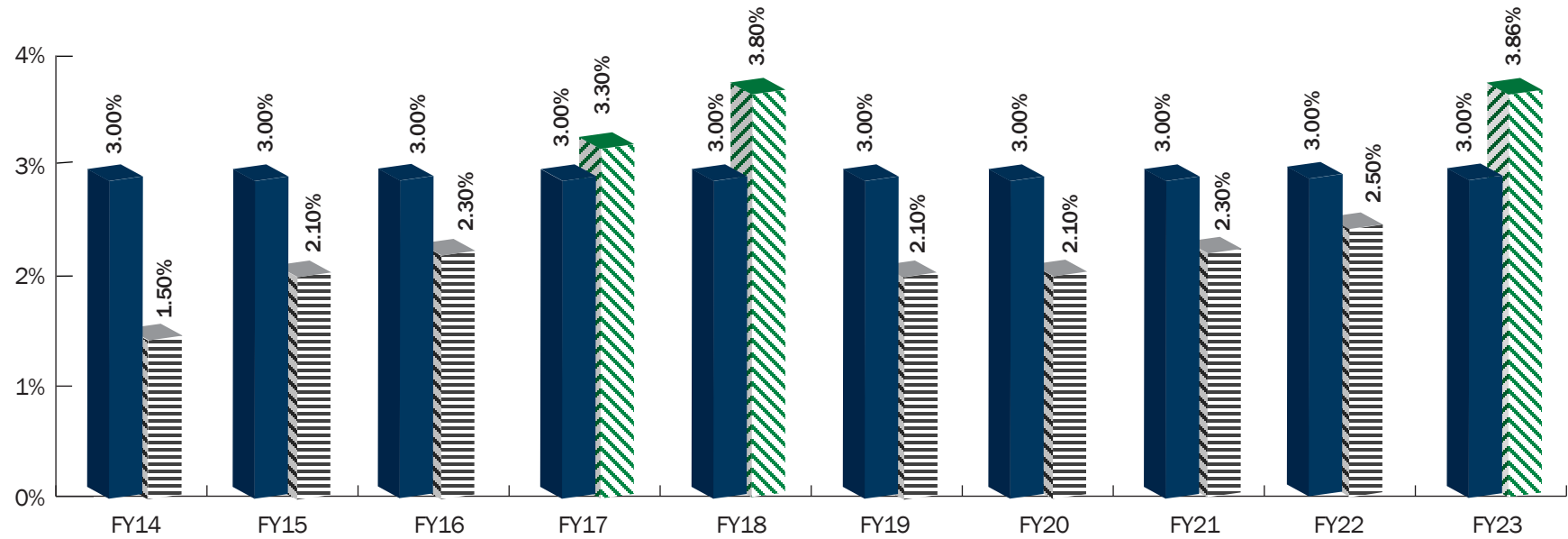
### HUBZone Prime Contracting Achievements

The chart below provides the HUBZone subcontracting achievements for FY 2014–2023.



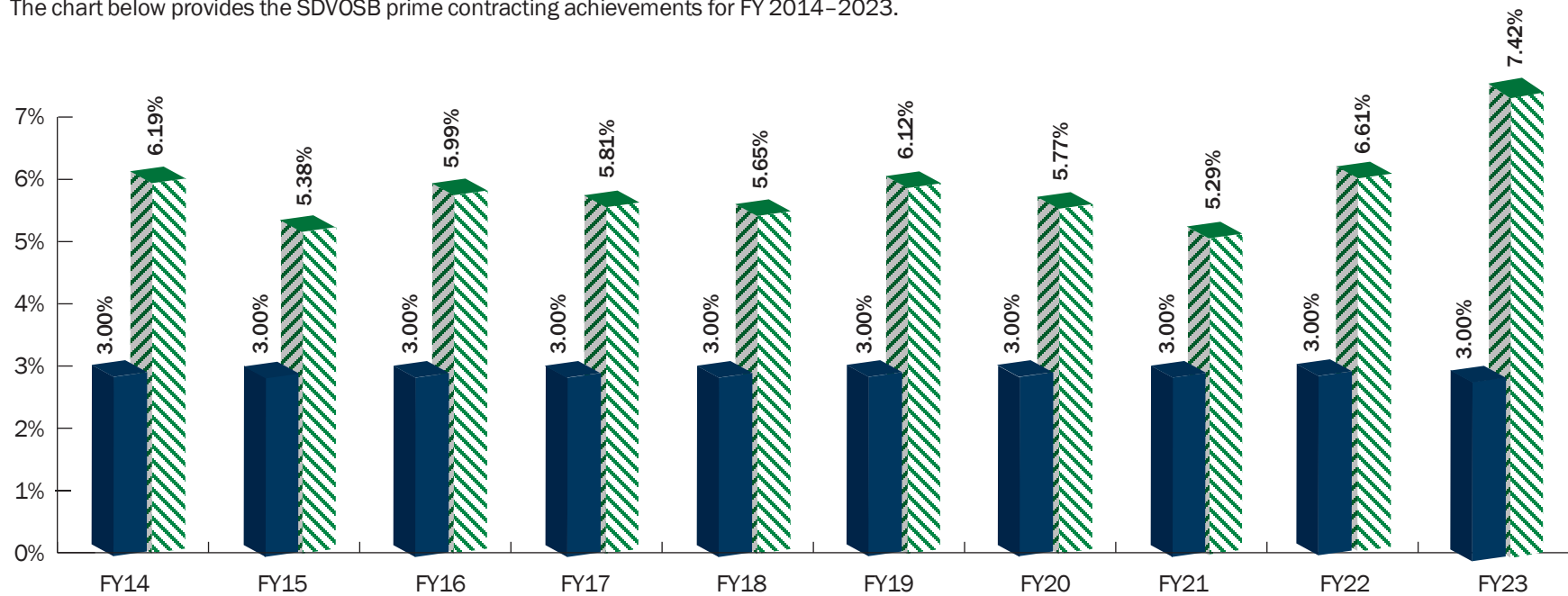


## Service-Disabled Veteran-Owned Small Business (SDVOSB) Achievements

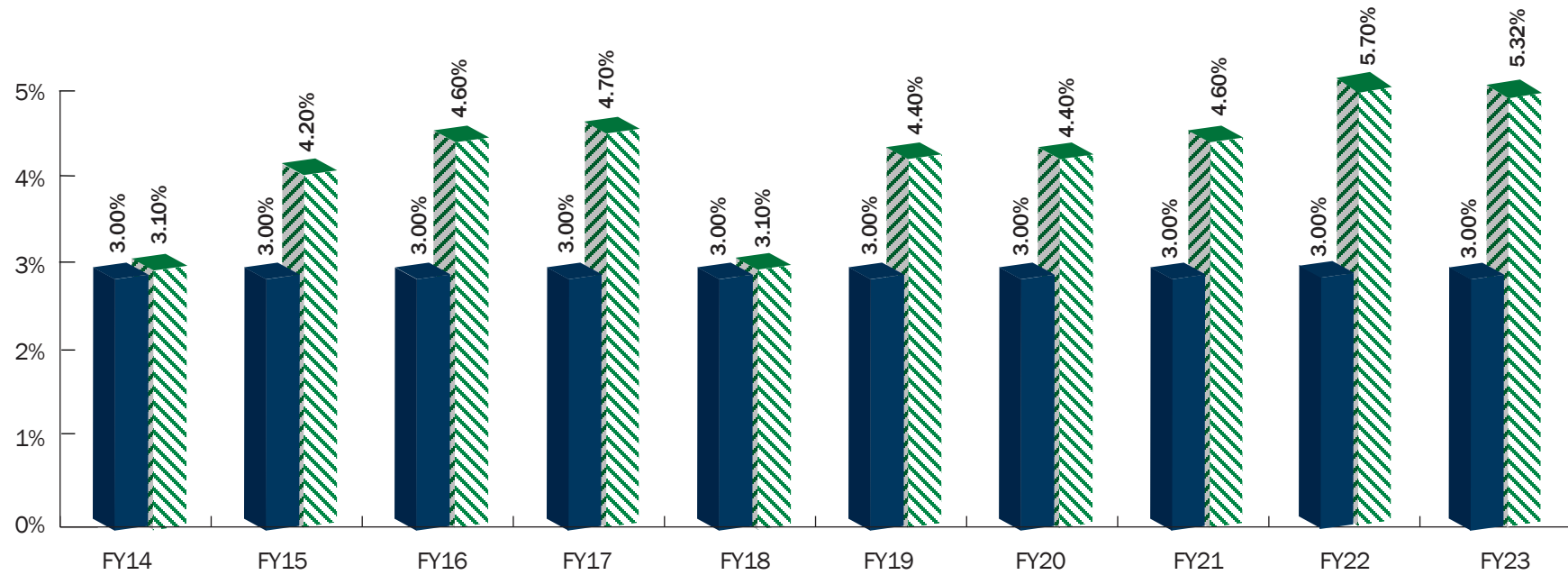
### SDVOSB Prime Contracting Achievements

The chart below provides the SDVOSB subcontracting achievements for FY 2014–2023.

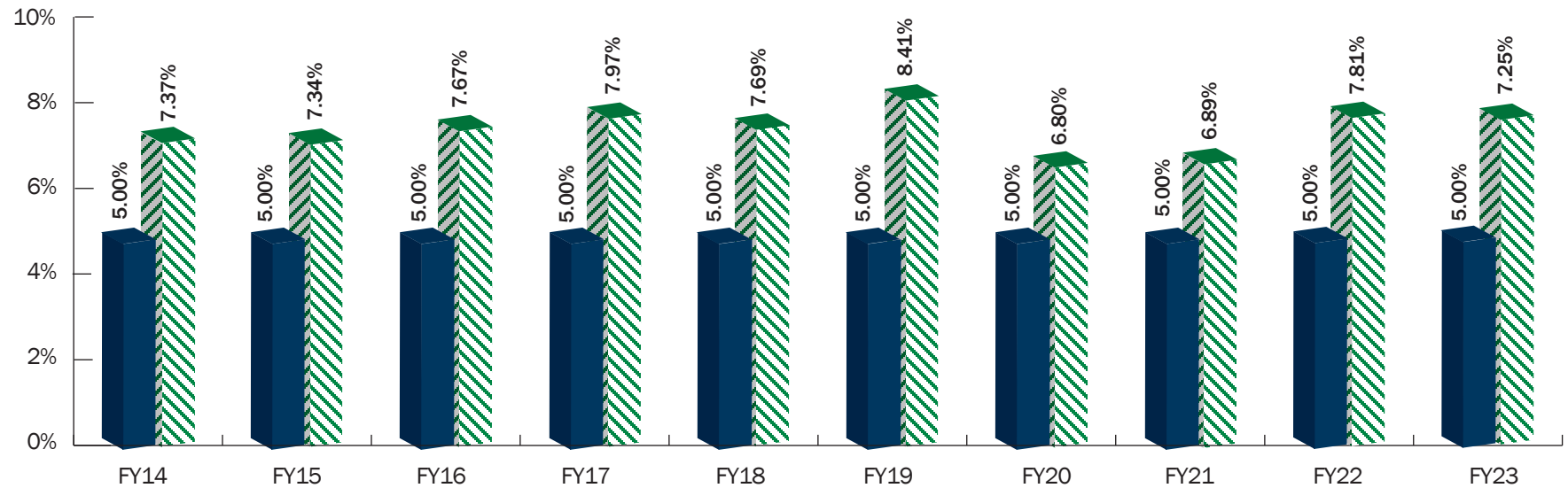


## Women-Owned Small Business (WOSB) Achievements

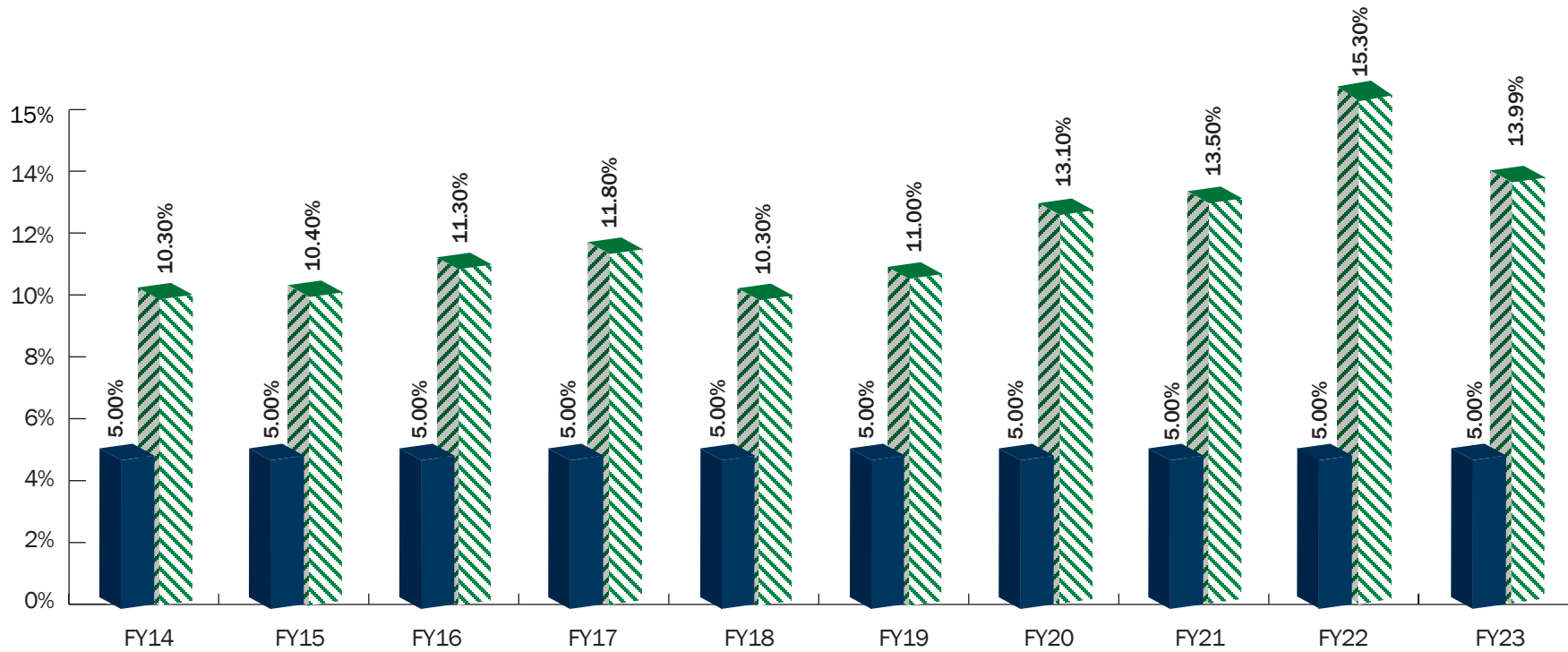

## Department of Homeland Security Small Business Scorecards

Each fiscal year, federal small business programs receive a letter grade of achievement (Small Business Procurement Scorecard) from the Small Business Administration (SBA). An agency's scorecard grade is determined by a number of factors, which are detailed in [SBA's Contracting Scorecard Grading Methodology](#).

Since SBA implemented a letter grade system for the Small Business Procurement Scorecard in FY 2009, DHS has received a grade of "A" or "A+" 14 years in a row (FY 2009 through FY 2023), the largest federal agency to have such a track record. More significantly, FY 2023 marked the seventh consecutive year the Department achieved a grade of "A+."
