I. Legislative Requirement

This report was compiled pursuant to a legislative requirement in the Fiscal Year (FY) 2024 Further Consolidated Appropriations Act (P.L. 118-47) and its accompanying Joint Explanatory Statement. The report provides the unfunded priorities for discretionary funding classified as budget function 050 (Defense).

P.L. 118-47 states:

- SEC. 531. (a) Not later than 10 days after the date on which the budget of the President for a fiscal year is submitted to Congress pursuant to section 1105(a) of title 31, United States Code, the Under Secretary for Management of Homeland Security shall submit to the Committees on Appropriations of the Senate and the House of Representatives a report on the unfunded priorities, for the Department of Homeland Security and separately for each departmental component, for which discretionary funding would be classified as budget function 050.
- (b) Each report under this section shall specify, for each such unfunded priority—
- (1) a summary description, including the objectives to be achieved if such priority is funded (whether in whole or in part);
 - (2) the description, including the objectives to be achieved if such priority is funded (whether in whole or in part);
 - (3) account information, including the following (as applicable):
 - (A) appropriation account; and
 - (B) program, project, or activity name; and
 - (4) the additional number of full-time or part time positions to be funded as part of such priority.
- (c) In this section, the term “unfunded priority”, in the case of a fiscal year, means a requirement that—
- (1) is not funded in the budget referred to in subsection (a);
 - (2) is necessary to fulfill a requirement associated with an operational or contingency plan for the Department; and
 - (3) would have been recommended for funding through the budget referred to in subsection (a) if—
 - (A) additional resources had been available for the budget to fund the requirement;
 - (B) the requirement has emerged since the budget was formulated; or
 - (C) the requirement is necessary to sustain prior-year investments.

The Joint Explanatory Statement includes the following direction:

Section 534. The agreement continues a provision requiring the submission of a report on unfunded priorities for which appropriations would be classified as the 050 Budget function category.

House Report 117-396 includes the following direction:

Section 532. The Committee continues a provision requiring the Under Secretary for Management to submit a component-level report on unfunded priorities classified as budget function 050.

II. Background

This report provides the unfunded priorities for discretionary funding identified as budget function 050 (Defense). The following DHS Components have funding identified as budget function 050:

- **Cybersecurity and Infrastructure Security Agency (CISA):** \$99,432,000 to support various cybersecurity activities and regional staffing enhancements, which are operations essential to the progression of the agency's mission.
- **Federal Emergency Management Agency (FEMA):** \$2,062,000 to provide funds for FEMA's Preparedness and Protection activities and programs, to ensure support for its national continuity mission-essential requirements under all-hazards conditions.

III. Unfunded Priorities – Function 050

						expand its influence and support to a prioritized set of critical infrastructure owners and operators whose services Americans rely on every hour of every day, CISA would increase the number of regional personnel responsible for delivering support to the Nation's critical infrastructure owners and operators. This increase provides an additional 90 CSAs and 30 PSAs to continue the growth toward 1 CSA in every Metropolitan Statistical Area with a population over 300K. It further provides an additional 10 ECCs to continue growth toward 1 ECC per state. The total requirement in the Report is 260 positions; this funding supports 130 positions because that is executable in a single fiscal year. The costs also include the additional required program funds to provide the travel and equipment these Security Advisors required to deliver the CISA services nationwide. With these additional Security Advisor resources, Integrated Operations Divisions would be able to support over 15,000 engagements annually, including 1,500 engagements in each Sector Risk Management Agency and 2,000 election engagements.
