- 9. Meaningful engagement with civil society members of all faiths, backgrounds, and interests and growth to over 20 metropolitan cities across the country; and,

DHS Celebrates National Native American Heritage Month

This month, CRCL, in partnership with the Society of American Indian Government Employees (SAIGE) DHS employee association, held the 2024 Departmental Native American Heritage Month commemorative observance. This year's theme, "Affirming Native Voices: Visibility-Leadership-Service," emphasizes the importance of the voices of the Native American community and their outstanding commitment to service. The program featured a panel of distinguished members of the DHS Native American Community.

During the discussion, panelists shared their inspiring stories of strength and leadership, underscoring the importance of family and community. During Native American Heritage Month, we



celebrate and honor the immeasurable contributions of the Native American community; the influence they have had on the advancement of our Nation, and the recommitment to upholding principles of fair and equal treatment, equal dignity, and equal opportunity for all American citizens.

CRCL Hosts Series of Virtual Community Engagements

This month, CRCL's Community Engagement Section hosted a series of virtual engagements with new community stakeholders in North Carolina, Michigan, Colorado, and Utah. CRCL conducts regular outreach to communities across the country to provide information about DHS programs and activities and to hear feedback and concerns regarding on-the-ground impacts of DHS activities.

In North Carolina, CRCL representatives met with new stakeholders and provided an overview of CRCL's mission and the work the office including how CRCL reviews and investigates allegations of civil rights and civil liberties violations, as well as how the public may submit complaints to CRCL. Attendees raised a number of questions involving immigration enforcement during disasters, deferred action, and asylum requests, among others.

In Michigan, CRCL conducted an introductory meeting with an immigration legal resources organization where CRCL representatives provided an overview of the office and took questions about CRCL's public complaint process, disability accommodations under Section 504 of the Rehabilitation Act, and how CRCL and DHS OIDO coordinate in their mission areas.

In Colorado and Utah, CRCL representatives met with new stakeholders and provided an overview of the office. Discussion topics included CRCL's complaint process and transnational suppression.
