- (b)(6) who is a United States Citizen filed a petition for her husband, (b)(6) at the end of 2014. After the case cleared from the department of homeland security, the case was sent to National Visa Center. As shown on the U.S State Department Immigrant Visa Application, the Immigrant Visa Case Number: (b)(6) VNN was created on August 5, 2015.
- On October 31, 2016 the National Visa Center at the U.S Department of State sent a letter to inform (b)(6)'s attorney, (b)(6) from the Carol Edward Law Office that Immigrant Visa Interview for her husband (b)(6) was scheduled on December 5, 2016 at the U. S. Embassy or Consulate in Vienna, Austria.
- As planned Mr. (b)(6) went the interview at the U.S embassy in Vienna at 01:00PM and his visa was issued on January 13, 2017. Mr. (b)(6) departed from Vienna, Austria on January 27, 2017 at 6:30PM where he was living temporarily as a refugee from Somalia who was affected by the turmoil and the political instability that Somalia was struggling to overcome last 27 years.
- Mr. (b)(6) told us that when he came to Seatac International Airport he was notified by the Immigration officials that according to the new executive order which is effective on 90 days they can't admit him into the Country and they notified him that he will be sent back to where he departed. He notified them through interpreter that he understands and abides the law that brought him here in the first place but he would like to inform his waiting wife and relative that he will be returned back.
- The customs and Border Security officials denied his request and told him that he is a prisoner and was not allowed to use any phone or to speak any body. His personal belongings including his phone and his visa papers were confiscated by the customs officials. Then he was escorted back to the plane by an immigration official.
- He told us that it was only when he sat in the plane that he asked help one of the passengers to lend him a phone in which he called his wife and informed what happened.
- He is in Vienna now and told us that he is not in detention but his immigration status is unknown.

- He told us that it was only when he sat in the plane that he asked help one of the passengers to lend him a phone in which he called his wife and informed what happened.
- He is in Vienna now and told us that he is not in detention but his immigration status is unknown.

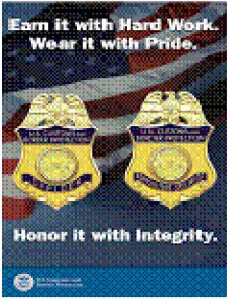
