DHS Responds to Hurricane Harvey

DHS Components have been assisting the Federal Emergency Management Agency (FEMA) in <u>Hurricane Harvey</u> preparedness and response activities. On August 25, U.S. Immigration and Customs Enforcement (ICE) and U.S. Customs and Border Protection (CBP) issued a <u>joint statement</u> reinforcing that their highest priorities are to promote life-saving and life-sustaining activities and safe evacuation, and therefore, non-criminal immigration enforcement operations will not be conducted at evacuation sites, or assistance centers such as shelters or food banks. The statement is translated into: Spanish, Arabic, Chinese, Korean, Vietnamese, Tagalog, and Urdu. FEMA also <u>published information</u> regarding sheltering for all individuals affected by the hurricane, including undocumented immigrants.

Additionally, CRCL has coordinated with FEMA's Office of Disability Integration and Coordination covering response activities involving individuals with disabilities and others with access and functional needs. CRCL and FEMA published guidance, "Tips for Effectively Communicating with the Whole Community," for disaster assistance providers highlighting effective communication practices to ensure non-discrimination in the provision of disaster-related services.

houses of worship in their communities, including mosques, churches, synagogues, gudwaras, and community centers, which have been the target of hate incidents, crimes, and violence. Any person who believes someone has been subjected to discrimination on the basis of race, color, national origin, disability, religion, sex or age in a DHS program or activity, may <u>file a complaint</u> with the DHS <u>Office for Civil Rights and Civil Liberties</u>.

CRCL Participates in Second Annual MELOA Diversity Training Conference

CRCL representatives recently participated in the second annual Middle Eastern Law
Enforcement Officers Association (MELOA) Diversity Training Conference in Dearborn,
Michigan. MELOA is a DHS-recognized association composed of Federal law enforcement
agents and officers from across DHS components. The two-day training focused on resiliency,
and brought together homeland security professionals, law enforcement, and community
members to learn about community-based policing best practices, suicide and opioid abuse
awareness and prevention, trauma informed policing, and implicit bias. CRCL provided a presentation
highlighting programmatic updates and community engagement best practices. A highlight of the discussion
focused on sharing contextual information on 'hot topics' related to civil rights and homeland security
potentially impacting law enforcement operations and the communities in which officers live and serve.

CRCL Leads Community Engagement Meetings in Minneapolis

CRCL's Acting Deputy Officer Dana Salvano-Dunn recently joined CRCL's Community Engagement Section in Minneapolis, Minnesota to lead the quarterly roundtable meeting and attend a series of engagement events with local stakeholders. Over 100 participants attended the roundtable held at the Hennepin County Sheriff's Office. Ms. Salvano-Dunn delivered an in-depth presentation on CRCL's statutory obligations and its complaints process. A representative from the Federal Bureau of Investigation (FBI) also presented on internet safety, social media, and cyberbullying, as requested by stakeholder parents and students.

While in Minneapolis, CRCL representatives also attended separate meetings with local community partners, including the Islamic Association of North America; Ka Joog, an organization focused on programs and services for Somali youth and their families; and Isuroon, a Somali women's empowerment organization. Discussion at these meetings covered allegations of profiling at a local airport, hate crimes and fear of attacks against local mosques, allegations of inadequate medical care at ICE detention centers, and



broadening CRCL's engagement efforts in Minnesota among other topics.

CRCL Acting Officer Leads EEO and Diversity Training

This month, CRCL's Acting Officer Veronica Venture spoke at the 32nd Annual Federal Dispute Resolution Training in San Francisco, California. The annual event offered in-depth training on a wide range of human resources, equal employment opportunity and diversity, and alternative dispute resolution matters.

Ms. Venture led a presentation called "Meeting the Challenge: Being a Model Employer of Employees with Disabilities," which covered recent Equal Employment Opportunity Commision final rules regarding individuals with disabilities in federal employment. Ms. Venture discussed strategies to achieve hiring and retention goals, ensuring reasonable accommodation proceduces, and creating funds for certain accommodations.



CRCL Leads Roundtable and Cultural Awareness Training in Columbus

Last week, CRCL representatives traveled to Columbus, Ohio to lead engagement activities with local community stakeholders and local law enforcement. During the quarterly roundtable, hosted by Ashland University, officials from DHS Headquarters, ICE, and the FBI presented on a number of topics. A representative from the DHS Office of Community Partnerships delivered a community awareness briefing on domestic violent extremism, and an ICE Community Relations Officer provided an overview of ICE and its current priorities and policies.

While in Columbus, CRCL representatives also met with law enforcement and other staff from the Franklin County Sheriff's Department to discuss CRCL's community outreach activities, as well as provide training on civil rights and civil liberties and cultural competency. The goal of the training was to improve communication, build trust, and encourage collaboration between officers and the communities they serve and protect. Topics covered effective policing without the use of ethnic or racial profiling and best practices in community outreach.
